S.O. 3386(E).—In exercise of the powers conferred by sub-section (3) of section 3 of the Environment (Protection) Act, 1986 (29 of 1986) and in pursuance of the notification of the Government of India in the erstwhile Ministry of Environment and Forests number S.O. 1533(E), dated the 14th September, 2006 (hereinafter referred to as the said notification), the Central Government hereby constitutes the State Level Environment Impact Assessment Authority, Arunachal Pradesh (hereinafter referred to as the Authority for Arunachal Pradesh) comprising of the following members, namely: -

2. The Chairman and non-official member of the Authority for Arunachal Pradesh shall hold office for a term of three years from the date of publication of this notification in the Official Gazette.

3. The Authority for Arunachal Pradesh shall exercise such powers and follow the procedures as specified in the said notification.

4. The Authority for Arunachal Pradesh shall base its decision on the recommendations of the State Level Expert Appraisal Committee constituted under paragraph 5 for the State of Arunachal Pradesh.

5. For the purposes of assisting the Authority for Arunachal Pradesh, the Central Government, in consultation with the Government of Arunachal Pradesh, hereby constitutes the State Level Expert Appraisal Committee, Arunachal Pradesh comprising of the following members, namely :-

6. The Chairman and Members of State Level Expert Appraisal Committee, Arunachal Pradesh shall hold office for a term of three years from the date of publication of this notification in the Official Gazette.

7. The State Level Expert Appraisal Committee, Arunachal Pradesh shall exercise such powers and follow the procedures as specified in the said notification.

8. The State Level Expert Appraisal Committee, Arunachal Pradesh shall function on the principle of collective responsibility and the Chairman shall endeavor to reach a consensus in each case, and if consensus cannot be reached, the view of the majority shall prevail.

9. The Government of Arunachal Pradesh shall notify an agency to act as Secretariat for the Authority for Arunachal Pradesh and the State Level Expert Appraisal Committee, Arunachal Pradesh, and shall provide all financial and logistic support including accommodation, transportation and such other facilities in respect of all its statutory functions.

10. The sitting fee, travelling allowance and dearness allowance to the Chairman and Members of the Authority for Arunachal Pradesh and the Chairman and Members of the State Level Expert Appraisal Committee, Arunachal Pradesh shall be paid in accordance with the concerned rules of the Government of Arunachal Pradesh.
