Whereas the Ganga Wildlife Range with headquarters at Ganga was created vide Govt. Notification No.FOR.330/78/1934-78 dated 23.01.1980.

And whereas its location has subsequently been shifted from Ganga to the present location at Zoological Park, Itanagar on 15.11.1986 vide order No.FOR.330/78/34892-937 dated 22.10.1986.

And whereas the Itanagar Zoo was renamed as Biological Park, Itanagar vide notification No.CWL/D/70/2000/409 dated 18.02.2003.

And whereas as a post of Director, Biological Park, Itanagar was created and notified vide Government of Arunachal Pradesh notification No.FOR.1145/EA/2006/23381-440 dtd 13.08.2009.

And whereas no formal Government order or notification creating an entity called "Zoo at Itanagar" (Zoological Park) was issued till dated and in the absence of it. the Director, Biological Park cannot be declared as "Cheque Drawing Authority" by the concerned authorities.

Therefore in view of the above position, the Governor of Arunachal Pradesh is pleased to accord ex-post facto sanction for creation of Zoo at Itanagar (Zoological Park) with retrospective effect from 15.11.1986.

This has the approval of the competent authority vide UO No.3320 dtd.16.12.2019.
