In reference to the subject cited above, it is to submit that despite issuing the work order on 26.03.2024 followed by subsequent reminders, this office has neither received the official confirmation from your side nor received any form of communication from you or your representative regarding the progress of work.



Your reply (if any) should reach to this office within **15 days** from the date of receipt of this show-cause notice or date of publication in the official website, whichever is earlier, failing which decision will be taken exparte, to an extent of black-listing the concerned firm.

As you are evading to receive the letters and responding to telephonic calls, the show-caused notice is being published in the official website for your response. This will be treated as serving the letter to you as sufficient. No further correspondence will be made to you in this regard.


